4. Buses must have internal facility and staff uniform etc. as per guidelines of the Apex court and instruction of District Administration.
5. Every bus must have a Driver with appropriate Driving License and one khalasi (Helper with ID Proof.)
6. The agreement and hire charges will be finalized for the period of 11 (eleven) months only from 01.07.2019
7. For any indiscipline or undesired activities, the agreement will be terminated with one month notice or payment in lieu of that.
8. The buses must be fuel efficient and fuel will be paid as per GPS reading of the distance.
9. The Base Rate be quoted inclusive of all the expenses except fuel (diesel).
